2008 Honor Roll Requirements

To Be completed and turned in by December 11, 2008

Required Elements

1.	Our Unit earned the Centennial Quality Unit Award for 2008. The Unit must meet with a Commissioner to mutually set the criteria for the Award which will be earned in 2008.
2.	Our Unit completed re-charter on or before Re-Charter Saturday, December 2008
3.	Our Unit held a conscientious Friends of Scouting (FOS) campaign where each family was given an opportunity to contribute before March 31, 2008
4.	Our Unit will be represented at the District Banquet in February 2009
5.	Our Unit has participated in one of the following Membership/Recruitment activities: Packs – <i>School Night for Scouting, Charter Organization Recruitment Drive</i> Troops – <i>host one or more Webelos Dens to two or more Troop functions, Venture Crews – hold a First Nighter or Open House</i>
6.	All registered leaders have received Youth Protection Training after January 1, 2006
7.	At least 50% of the youth in our Unit attended a long term outing. Packs – <i>Day Camp, Council Summer Family Camping or Webelos Encampment</i> Troops – <i>Summer Camp or High Adventure outings.</i> Crews – <i>Venture Camp, High Adventure outing</i>
8.	All Troops must have their Merit Badge Counselors registered with the District Advancement Committee <i>(This is not a requirement for Packs and Crews).</i>
9.	All Packs must have a Baloo Trained Leader that is registered with the Cub Activities Committee. <i>(This is not a requirement for Troops and Crews)</i>

All elements must be completed as written to qualify for this award. No exceptions will be made.

This will certify that our Unit has met all of the required elements listed above and nine of the thirteen elective elements indicated on page 2 to meet the 2008 Honor Roll Requirements making members of our Unit eligible to wear the Chicken Pin for 2008.

Elective Elements (complete 9 of 13)

1.	Our Unit attended nine out of twelve Roundtables in 2008
2.	Our Unit participated in an organized, Council approved product sales or fund raising campaign that allows each youth member the opportunity to “earn his way” in the Unit’s program.
3.	Our Unit participated in a uniform inspection conducted by a Unit Commissioner
4.	Our Unit attended or participated in a Scout Sabbath or Scout Sunday event.
5.	Our Unit provided two or more opportunities for family participation (<i>Court of Honor, Blue & Gold Banquet, Family Cookout, Family Camping, Pinewood Derby, etc.</i>) <i>Do not count normal Troop, Pack or Crew Meetings.</i>
6.	Conduct a Merit Badge Clinic or a Webelos Activity Pin program that invites another Foothills District Unit than your own to participate and earn a Badge. Venture Crew should share an activity with another Crew other than your own.
7.	Our youth have participated in at least two District/Council events. (<i>Camporees, Webelos Woods, Day Camp, Derby Days, Cub Family Camping, Cub World Events, Scout Expo, District YLT, Den Chief Training, Council Venturing Events, Venturing Roundtable, Venturing Leadership Skills, etc.</i>)
8.	Our Unit has participated in providing Community Service in 2008 and logged the service hours at www.GoodTurnforAmerica.org
	<i>(Allatoona Cleanup, Adopt-a-mile, Adopt-a-Stream, Scouting for Food, US 10K Classic, US Park Service, Kennesaw Mountain, Eagle Projects or others as approved by the Program Vice Chair)</i>
9.	The active Key Leadership in our Unit (All Unit Leaders, Committee Chair, Den Leaders and Assistant Scoutmaster/Advisors) have completed basic training for their current position after Jan 1, 2006.
10.	Adult leaders have participated in an advanced training opportunity (either as a participant or on staff) in 2008 on a formula of at least one leader for every 15 registered Scouts. (<i>Baloo Training, Scouters Academy, Wood Badge, Powder Horn, Certification Saturday, National Camp School, Climbing Instructor, COPE Instructor, Trainer Development, Safe Swim Defense, Safety Afloat, Climb on Safely, NYLT, Wilderness First Aid, BSA Lifeguard, Red Cross Lifeguard, SWC</i>)
11.	Our Unit provided leadership to a 2008 District/Council Committee or Commissioners Staff based on a formula of at least one volunteer for every 15 registered Scouts. (<i>Advancement, Camping, Communication, Community Activities, Cub Activities, Finance, Health & Safety, Membership, Public Relations, Religious Relations, Training, ADC, Unit Commissioners or Roundtable Staff</i>)
12.	Our Unit provided Staff to one or more 2008 District events based on a formula of at least one volunteer for every 15 registered Scouts. Troops and Crews may use Youth volunteers to qualify for this element. (<i>Camporees, Webelos Woods, Day Camp, District Cub Family Camping, Scout Expo, District YLT, SWC, FOS Presenter/Section Chief/Table Captain</i>)
13.	Have a joint activity with a Unit from another Scouting level other than your own. (<i>Pack & Troop activity – Troop & Venture Crew activity – Pack & Venture Crew Activity Varsity Team and any Pack/Troop/Crew</i>)

Note: Formula requirements mean if you have 30 Registered Scouts in your Unit, then you will need 2 Leaders to meet the requirement. If you have 45 Registered Scouts it would require 3 Leaders to meet the requirement. Any Unit with 29 or less registered Scouts would require at least one Leader to meet the requirements.
